

- 2. Bass Pass: We will be using the KS "BASS PASS" in this event, but purchase and use of the Bass Pass is optional per angler. Any angler using the Bass Pass will be allowed to keep 15" bass. If only one member of the team has the Bass Pass, then only that member can keep 15" bass. If not using a Bass Pass, fish must meet the 18" minimum length limit.
- 3. **Basic Boating Equipment:** Every tournament boat must have all required Coast Guard Safety Equipment. Each boat must have a functional bilge pump and live well space, properly aerated, capable of keeping alive one limit of fish per team.
- 4. **Safety:** Safe boating must be observed at all times. Each contestant is required to wear an approved personal floatation device, snapped and zipped, anytime the combustion engine is operated above an idle speed while pre-fishing and fishing. All boats must be equipped with an ignition shut-off device securely attached to the boat operator when the boat is operated above idle speed while pre-fishing and fishing.
- 5. **Sportsmanship:** All competitors are expected to follow high standards of sportsmanship, courtesy, safety, and conservation. **NO ALCOHOLIC BEVERAGES** are allowed on the premises during the event. Violators will be disqualified with no exceptions.
- 6. **Anglers, Tackle and Equipment:** No more than two (2) anglers per boat. No trolling will be permitted. NO live bait or prepared bait will be permitted, with the exception of pork strips, rinds, etc. Only one rod and reel per competitor is permitted in the water at any given time.
- 7. **Permitted Fishing Locations:** Fishing on the tournament water is permitted anywhere except where noted on the lake. Please stay at least (25) twenty-five yards of another competitor's boat unless invited or if both boats are working opposite directions towards each other on a bank.
- 8. **Official Check Point:** There shall be only one official point for check-in in the morning and weigh-in, in the afternoon. The Tournament Director shall designate this point on the day of the tournament.
- 9. Late Penalty: Any competitor showing up at check-in location after tournament end time will be penalized 0.25 lbs of weight per fish per minute of Tardiness, and disqualified after 15 minutes. NO EXCEPTIONS!
- 10. **Your Catch:** Only largemouth or smallmouth bass will be weighed. Only bass described above which measures at the (18") eighteen inch mark shall be weighed in, unless utilizing a KS Bass Pass (see item #2 above). Legal size limit shall be in accordance with the rules and regulations of the state of Kansas and Melvern Lake. Short fish brought to weigh in result in disqualification. Each fish will be measured at weigh-in by the tournament committee. A quarter of a pound deduction will occur if any fish is weighed in that is no longer living or considered dead. Tournament director's decisions are final.
- 11. **Ties and Scoring:** Tournament winners will be awarded by largest individual weight of each fish species (one largemouth and one smallmouth), with separate winners declared for each species respectively. Ties will be broken by order of tournament registration. Payouts are 1/3rd to each species winner and 1/3rd to OBC. If no fish is weighed of one particular species, the second largest bass will receive the remaining 1/3rd.
- 12. **Knowledge of these rules is your RESPONSIBILITY:** Failure to read these rules or Ignorance of these rules is no excuse... Any announcement made by the Tournament Director at tournament site takes precedence over any written rules.
- 13. **Acknowledgement:** By signing this entry form you hereby release Olathe Bass Club, all other contestants, the host, agents, employees, firms which will receive advertising and/or promotional consideration, and Tournament Officials from all damages, claims, demands, cost of expenses relating to injury we may sustain or which we might cause by reason of participating in the above tournament.


